I accept and acknowledge the receipt of this puppy with the following conditions:

To the best of the seller's knowledge, this puppy is healthy and free from all diseases and has received all of its proper deworming and vaccinations in accordance with its age. Buyer agrees to take the puppy to a licensed vet within 72 hours of purchase for a health check. If the buyer does not take the puppy to a licensed vet within 72 hours this contract becomes void.

If the puppy is found to be unhealthy with a life-threatening hereditary defect, the buyer must present to the seller written documentation from a vet. The seller MUST be notified within 48 hours. The documentation must include the vet's name, phone number, signature, and description of the problem. Seller reserves the right to contact the vet and/or have their own vet examine the puppy before any action is taken. Seller must be notified as soon as possible to discuss options for a replacement puppy of equal or lesser value once the puppy is returned. Buyer is responsible for returning the puppy back to the seller. Replacement puppy will be honored at the seller's discretion; it may take up to one year for replacement. There will be NO CASH REFUNDS for any reason with no exceptions.

The seller does not guarantee against conditions brought on by stress and/or environment changes such as: hypoglycemia, coccidiosis, giardia, kennel cough, bacterial infections, diarrhea, dehydration, or other related treatable health conditions. The seller will not be responsible for parvovirus, distemper, or corona virus after 48 hours. These are highly contagious diseases and they can be contracted immediately after leaving the seller's care. There are no guarantees on hernias and retained testicles, if repaired they are not life threatening. Seller does not guarantee against accidents, neglect, or abuse, nor the compatibility with your current pet.

This puppy is sold as a pet quality puppy and may have imperfections or blemishes. This puppy has no guarantee on fertility, size, or conformation. Buyer agrees to continue vaccinations, deworming, and proper health care of the puppy. Puppy registration papers and shot record have been provided with the puppy at the time of sale. Seller will not be responsible for any vet bills or other related fees after the time of purchase.
